Payment due dates vary by the type of rental period. Refer to your invoice or permit for details. Rental permits may be cancelled for overdue payments. No access to fields, tracks, or velodrome that are covered in snow. The velodrome may be closed due to the surface being wet. Fields may be closed due to inclement weather. The field Status Tool is updated weekdays by 4 p.m., and on weekends at 9 a.m. and 1 p.m. User groups are not allowed to remove snow from any athletic park assets including artificial turf and tracks. Snow removal is not available at The Calgary Soccer Centre or Ernest Manning Athletic Park; Snow removal at Shouldice Athletic Park is not always guaranteed and is subject to type of snow, volume and weight.
