Failure to observe facility regulations including — but not limited to — failure to meet payment deadlines, subletting, verbal, physical abuse, alcohol, or drug use while on site may result in consequences including the cancellation of permit(s) and loss of renewal privileges. The City of Calgary is not responsible for lost, stolen or damaged items. Booking groups must notify City of Calgary staff immediately if an injury occurs.

Booking groups and participants will be allowed access onto facilities (fields) at START of the booking time and are required to vacate field at END of the booking time. Setup and teardown must occur during the booking period, not before or after. Booking groups will not have exclusive use of common area around the facilities. All facilities and surrounding areas on property are to be left in a condition equal to or better than found. Damage to property will result in minimum fine of \$250.00. Change Rooms are change only, store gear in lockable storage boxes outside change rooms (Annex) or in gear storage area of players benches. Items cannot be left in these boxes for extended periods or overnight. Locks will be cut, and items left in boxes placed in lost and found nightly. The City is not responsible for any damage and or loss of personal property.


