The fee covers up to 10 changes per permit, per change submission. Cancellations or changes can be submitted via the online amendment request form at http://cocnmp.com/amendmentform/. Payment due dates vary by the type of rental period. Refer to your invoice or permit for details. Rental permits may be cancelled for overdue payments. Payments are accepted online at https://liveandplay.ca/gary.ca/HOME/public/page/home using the same email address listed on your rental permit or by phone during regular business hours.

No access to fields, tracks, or velodrome that are covered in snow. The velodrome may be closed due to the surface being wet. Fields may be closed due to inclement weather. User groups are required to check the field status on the day of booking at https://www.calgary.ca/rec-locations/athletic-parks/status.html. The field Status Tool is updated weekdays by 4 p.m., and on weekends at 9 a.m. and 1 p.m. User groups are not allowed to remove snow from any athletic park assets including artificial turf and tracks. Snow removal is not available at The Calgary Soccer Centre or Ernest Manning Athletic Park; Snow removal at Shouldice Athletic Park is not always guaranteed and is subject to type of snow, volume and weight.


