The field Status Tool is updated weekdays by 4 p.m., and on weekends at 9 a.m. and 1 p.m. User groups are not allowed to remove snow from any athletic park assets including artificial turf and tracks. Snow removal is not available at The Calgary Soccer Centre or Ernest Manning Athletic Park; Snow removal at Shouldice Athletic Park is not always guaranteed and is subject to type of snow, volume and weight.
