No removal of grass fibres or infill material. Alert coaches/game officials if clean up on field is required. Not permitted: driving stakes, bikes, rollerblades, skateboards, dogs, food, gum, seeds, nuts, sports drinks (water only), tobacco products, glass, sunscreen, oils, creams, hard nylon or metal cleats. Footwear allowed: single molded rubber cleats with a max 1/2 inch rubber screw cleat, or running shoe.
